



Funding

(SkillsConnect ID: CRS-N-0046693)

Singapore Citizens (SCs) and Permanent Residents (PRs) are eligible for funding support of 50% of course fees, capped at \$15 per training hour.

SCs and PRs who are sponsored by SMEs, or those who are eligible for Mid-Career Enhanced Subsidy (MCES) or Workfare Training Support (WTS) schemes enjoy higher funding support.

Registration & Payment

- Apply through post or walk in at the Customer & Visitor Centres (CVC) @ any of the 3 ITE Colleges
- Submit the application form and supporting document(s) on educational certificate(s). Bring along your NRIC or valid workpass.

Payment is required for confirmation of place. Crossed cheque must be made payable to "Institute of Technical Education" or "ITE". At the back of the cheque, please write your name, NRIC/FIN, Course Title and contact number.

Closing date: 2 weeks before course start date or when the class is full.

Withdrawal & Deferment

Withdrawal or deferment notice must be made in writing :

- 2 weeks or more before course start date
- Full refund
- Less than 2 weeks before course start date
- 50% refund
- On or after course start date - No refund

In the event that the course is cancelled due to unforeseen circumstances, full refund will be given.
