### Funding (Valid till 31 Dec 2027)

(SkillsFuture Course ID: TGS-2022011375)

Companies sponsoring their staff are eligible for course fee funding and Absentee Payroll funding.

Small Medium Enterprise (SME) and Singaporean age 40 & above are eligible for enhanced funding rate.

### Registration & Payment

### Withdrawal & Deferment

Withdrawal or deferment notice must be made in writing :

## Joint ITE-NEA Certificate in Pest Management

### Objective

Trainee are able to carry out pest inspection work, prepare work site for pest management, use pesticides and pest management equipment, prepare pesticides and supervise pest control operations performed by workers hired by the company.

### For Whom

Workers planning to apply to NEA for the Vector Control Technician license.

### Entry Requirement

- Singapore Citizens / Singapore Permanent Residents or Foreigners with a valid work pass; **AND**
- Have Provisional Vector Control Technician (VCT) licence; **OR**
- Completed GCE 'N' Level or higher; **OR**
- Attained Workplace Literacy & Numeracy (WPLN) Level 5 in Reading, Listening and Numeracy; **OR**
- Passed Pest Control Course with at least one year of working experience in vector control works

### Content

- Practise work safety
- Inspect pest and vector breeding and harbourage site condition
- Supervise pest and vector management
- Prepare pesticides for pest and vector management

### Certification

Trainee will receive the Joint ITE-NEA Certificate in Pest Management upon successful completion of 2 practical and 1 theory assessments, and satisfying the attendance criteria of 75%.

### Course Details

Duration : 66 hours (21 sessions)

[Classroom Training - 30 hours, Practical – 31 hours, Assessment – 5 hours]

Full Fee: \$741.20 (include GST) for Foreigners with valid work pass & Participants repeating the course
