



## NOTES TO APPLICANT

### 1. Applying for award of Advanced Certified Industry Trainer (ACIT)

#### Part A: Eligibility

You must satisfy **ALL** requirements to apply for the ACIT:

- (i) Possess **minimum Nitec** or equivalent qualification \*or references / testimonials of relevant past work experience
- (ii) Passed all three modules of Train The Trainer Programme: (1) Prepare & Conduct Coaching, (2) Deliver & Facilitate Learning and (3) Design & Develop OJT Programme. These modules must be attained **within the last 6 years**; and
- (iii) Possess at least three years of relevant working experience.

#### Part B: Fee payable

For each application, a **non-refundable** fee (inclusive of GST) of \$50.00 and \$50.47 is payable for Singapore Citizen (SC) and Non-Singapore Citizen (non-SC) respectively.

#### Part C: Submission procedure

Refer to checklist (page 2) for the list of documentary evidences to submit.

Send your completed application form and the relevant documents indicated in **the checklist** together with a cheque payment of **\$50** (for SC) **or \$50.47** (for non-SC) (payable to **ITE or Institute of Technical Education**) to **Skills Training & Services Department, Institute of Technical Education, 2 Ang Mo Kio Drive, Singapore 567720**

### 2. Evaluation Process

Your application will be evaluated for eligibility based on the **fully completed** forms and documentary evidences. Incomplete submission will **not** be processed and application fee will be forfeited.

ITE reserves the right to verify the documents submitted, contact you to seek clarifications or request for other supporting documents, and contact the organisation(s) stated for verification when making an assessment on your application.

### 3. Award of certificate

You will be awarded the ACIT based on the fully completed form and required documentary evidences. You will be informed of the outcome by email.

ITE reserves the right of final decision on the application. No appeals for re-evaluation will be entertained. You can reapply after receiving the official notification of the rejected application.

### 4. Declaration

All information furnished in the documentary evidences must be complete, accurate and verifiable. You may be required to provide addition information and documents if necessary.

### 5. For freelance trainer

You may submit letter of endorsement by the organisation in which you had conducted training, **or** at least two endorsed testimonials from the company which engaged your training services, **or** other relevant documents of proof of acquiring the training experiences.
