This form may take you 15 mins to fill in. You will need the following documents to complete the form: Your NRIC or Work Permit card. 1 2

Your Education and Training certificate(s).

PART A: ELIGIBILITY

- 1. You must satisfy **ALL** 4 requirements to apply for the Industry Trainer Certificate (ITC):
 - 1.1 Possess minimum Nitec (NTC-2) or equivalent qualification;
 - 1.2 Passed all 3 modules: Prepare & Conduct Coaching/ Coaching Skills, Deliver & Facilitate Learning / Instructional Skills and Design & Develop OJT Programme / Plan & Implement OJT. These modules must be taken within the last 6 years;
 - Possess minimum 6-months of post-training experience after the completion of the 3 1.3 modules: and
 - Possess at least 3 years of relevant working experience. 1.4

PART B: FEE PAYABLE

2. A non-refundable fee of \$50 (inclusive of GST) is payable for each application.

PART C: SUBMISSION PROCEDURE

- 3. Complete **all sections** and attach the following documents:
 - 3.1 Copies of relevant certificate(s) under s/n 1.1 and 1.2, and where applicable, official transcripts as well as information on the subjects and duration;
 - 3.2 A copy of Task Analysis (TA), Assessment Checklist (AC), Coaching Session Plan (CSP) and Lesson Plan (LP). The documentations on TA, AC, CSP and LP are to be based on the same OJT Task, and not to be assignments submitted during course attended:
 - 3.3 A list of Training/ Courses conducted after completion of the 3 modules; and
 - The documents under s/n 3.2 and 3.3 must be endorsed by your organisation. Freelance 3.4 trainers may submit documents endorsed by the organisation in which they had conducted training.
- 4. Send your completed application form and the relevant documents indicated in paragraph 3 together with a cheque payment of \$50 (payable to ITE or Institute of Technical Education) to Industry Training Department, Institute of Technical Education, 2 Ang Mo Kio Drive, Singapore 567720.

PART D: EVALUATION PROCESS

- 5. Your application will be evaluated for eligibility based on the fully completed form and documentary evidences. Incomplete forms will not be processed and application fee will be forfeited.
- 6. If you are eligible, you will be required to attend a 15-min interview. You will be assessed on your ability to explain how you coach/instruct/conduct OJT for your trainees during the interview.

PART E: AWARD OF CERTIFICATE

- 7. You will be awarded the ITC if you pass the interview. You will be informed of the outcome by post.
- 8. ITE reserves the right of final decision. No appeals for re-evaluation will be entertained.

PART F: DECLARATION
